Introductions completed

1. Additions / changes to the Agenda:

- ii) Graham Nishikawa added the request to give \$ awards to NST members
- iii) Jean-Paul Molgat would like to an item about CCY Bylaws
- 2. Adoption of Agenda: was moved by Anett Kralisch and accepted by all.

3. Approval of the March 27th Minutes

Jean-Paul requested that the phrase "Affiliate Reps" be changed to "Director (WCCSC)" in the these Minutes and in future "Director (WNSS)".

Moved to accept the changes was made by Dominic Bradford. All in favour.

4. Approval of April 8th Minutes

5. Board code of conduct (Matthias)

i)Safe Sport training for board members- All Board members will have to take Safe Sport training.

Discussion followed re Board Code of Conduct and whether the Safe Sport Code of Conduct Policy was sufficient at this time and whether it included Board

members. Some members felt it was not sufficient and others did not believe that with all that was going on there was time to work on another one. Some time was spent navigating the CCY website and identifying where the policies are. However it was clear that Board/Committee members and staff are all covered by the Safe Sport Policies. The old policies are still on the website because they have had to be provided with funding applications. Jen has had discussion bringing up someone to do athlete/parent/coach/official Safe Sport presentations.

ACTION: All Board members -Division and Club will have to take Safe Sport training. At this point we are waiting for information and direction from Nordiq Canada. Jean-Paul noted that he hopes any training will be more than the self-directed multiple choice type of training, and that the higher your responsibility the more training should be required.

A link should be added so that people can go between the Safe Sport and Governance documents easily.

- iv) Squad rep. Board/Director or committee position? (Jan McF, Matthias) The role of the Squad Rep committee is primarily as a liaison between the athletes, parents and the Board. The Squad Rep Committee Chair sits on the board. The Squad rep committee is very involved in assisting Jen MacK with events (Halloween, Valentines etc), hat embroidery/distribution, various other volunteer roles as well as planning the All Squad Family Christmas party. Jan was clear that, at minimum, there needs to be a coordinator of the squad rep committee if not the continuation of the squad rep committee chair position as it is currently. Given the liaison role between parents and athletes and the board, recommend that the Chair position continue and that it be a parent with a child/athlete in the squad programme. There should be a squad rep committee member on the board in case there is an issue. She is

meeting with Corinna and Michelle next week to sort out finances of the ski squad account (extracurricular fees, camps, coach gifts etc) and how best to manage these funds going forward.

Decision was to continue with a Squad Rep Committee Chair role on the board.

Jean-Paul stated that the slate is accepted at the AGM and then at the first meeting the actual positions would be decided. Jean-Paul suggested that every potential director write a one pager to introduce themselves and outline their skill set, and what they are interested in working on as per the strategic plan/vision.

vii) Bylaws-

Jean-Paul would like some wording checked in the Bylaws. Previous Bylaws has stated that ".... dues were determined by the Board and voted on at the AGM.."

Now it states, "... determined by the Board." He believes this was an error when the Bylaws were rewritten and the wording should go back to the earlier version.

Jean-Paul also stated there is reference to Insurance and that this is unusual in Bylaws. Discussion about membership and who was a member of Nordiq Canada. Divisions and License holders are members of NC.

Jean-Paul would like the Bylaws to be rewritten and presented at the AGM. Most felt that this was not a task that could be completed in a 6 week period, and that it would be better to defer the rewriting of the Bylaws to another

time. Jean-Paul said he would prepare a paper and send it around as he felt there was time.

ACTION: Move forward with a plan to look at the Bylaws in the next 6 months.

ii) Feedback received from Brian Horton

Brian had sent an email about his experience this past season. He shared that he had some struggles with parents and athletes over the season. Examples included, but were not limited to: the fundamentals of fair play and sportsmanship; supporting skiers to arrive on time, stay for the whole practice; not understanding that the coaches work as a team and are in constant communication. Some parents may have wanted to overturn and appeal decisions. At times there was an undermining of the volunteer coaches.

Discussion ensued about how to educate all parents. All families must have the same information and understand the program and how they can best support their athlete. In the past there have been parent meetings for each squad. Sometimes it is difficult to get buy-in for attending a meeting, "It's my 2nd/3rd child...."General consensus is that a parent/athlete meeting is essential. Jen has sent a survey out to parents but it was mostly about selecting the best time for training sessions and how race communication could be improved.
