• Financials update (Michelle)

Michelle had sent around the current financial docs yesterday. Shows a deficit of \$10,000 which is concerning. There are some grant \$ and travel \$ still pending. Enhanced Athlete development and Podium \$

Graham talked to Trevor T from Sport and Rec and understands that CCY has not received the last 25% which is \$42,000. He has submitted the documents to receive that outstanding contribution.

A canceled trip has resulted in some credits in Jen and Graham's accounts which won't be used until next year.

## Review Programming Fees

-Some of the Club's Board met with YG Ministers Two main topics

#1 The functional needs of the stadium and outbuildings. Deficiencies in snow making facilities near the stadium, particularly water and power. Washrooms are also lacking. Generally they seemed interested. The Club has grown almost 50% since the pandemic.

#2 Land tenure - Gladiator Metals claims cover part of the Copper Trail. It has been a theoretical threat since 2008 but is becoming more real. WCCSC is looking for solutions to protect the trails. McIntrye Creek Park could be key to that.

5 parties need to sign any MOU -2 FN and three levels of government. Atco parcel is a crown grant - subsurface private ownership of the minerals Surface was severed and sold to ATCO covers almost all of the Pierre Harvey Loop.

An Open House will be held on March 6th to share information about the proposed name change of the Club.
