# 6. Review Treasurer's Report and financial review

Michelle Leach provided a walk through of her financial statements.

A Sport Foundation Grant of \$15,000, was received which enabled CCY to finish the year with a small surplus of \$354.65

Financially Cross Country Yukon is very healthy. We have an internally protected fund of \$ 100,000 to allow for fluctuations in funding.

Revenues were higher than the year before. Many athletes travelled, which correlated with higher travel expenses, but also brought increased contributions from athletes. Expenditures were higher, and we saw Increases in almost every category.

Our final Balance Sheet is in a similar position as last year.

We need to be very mindful that costs are increasing, while for the most part, our revenues are static.
